ALLIEBECK STUD SERVICE CONTRACT

This Alliebeck Stud Service Contract (this "Contract") is entered into this _____ day of _____, 20__, by and among Alliebeck and _____, (herein called "Owner", whether one or more) the owner(s) of the herein described Bitch. Alliebeck and Owner hereby agree to the following terms and conditions of stud service from the Stud Dog, as described below.

Check One:

- The Stud Dog is GCH CH Alliebecks For Pete's Sake SDHF BVISS, AKC#SR285191/01, Microchip No. 091 533 613, DNA Profile #:V627328, born May 24, 2005 (if checked, herein called "Stud Dog").
- The Stud Dog is Bronze GCH CH Scions Southern Man MBISS, AKC#SR543753/05, Microchip No. 031 852 612, born January 28, 2009, CHIC #71335 (if checked, herein called "Stud Dog").
- The Stud Dog is CH AlliebeckHighmark Dreams To Remember BISS, AKC#SR706412/01, Microchip No. 068 817 517, DNA Profile #V728184, born November 3, 2011, CHIC #96000 (if checked, herein called "Stud Dog").

Alliebeck agrees to provide stud services to the bitch described as _____, AKC# _____, Microchip No. or Tattoo _____ (herein called "Bitch"). The Bitch has the following clearances: Hip OFA# _____, Elbow OFA# _____, Eye CERF/OFA# _____ (dated within last 12 months) and Heart OFA# _____ (herein collectively "Clearances"). Owner represents and warrants (a) it is the owner of the Bitch and has the authority to enter into this Contract, (b) the listed Clearances are those of the Bitch and (c) the Bitch presented or used under this Contract is the Bitch described above. Owner agrees, as a condition to this Contract, to provide copies or valid evidence of the Clearances of the Bitch to Alliebeck.

The stud fee ("Stud Fee") for the stud services provided hereunder shall be \$1,200 payable as follows: (a) \$500 payable within 3 days of execution of this Contract and prior to any breeding or shipment of semen and (b) the balance payable upon determination of the whelp of 3 or more puppies but no later than 10 days after whelping. The Stud Fee must be paid in full prior to Alliebeck's execution of the litter application. In the event 3 or more puppies are not whelped at no fault of Owner, Alliebeck agrees to provide the stud services from the Stud Dog to the same Bitch on the Bitch's next heat cycle only, provided the Clearances are current or a new CERF/OFA is provided in the case of a renewed CERF/OFA and a current Brucellosis Certificate is provided in the case of a natural breeding. If the Bitch is not bred on the her next heat cycle for whatever reason, then Owner's deposit shall become non-

refundable and Alliebeck shall not be required to provide further stud services under this Contract. If the inseminating veterinarian finds that the semen to be of poor quality at the time of insemination and cause for the non-pregnancy, Alliebeck agrees to pay for the expense of the collection of the Stud Dog's semen and shipment relating to the rebreed. If a second breeding does not result in a whelp of 3 or more puppies regardless of the reason, no refund on the breed shall be provided.

At Alliebeck's election, a show quality puppy may be taken in lieu of the Stud Fee.

All expenses relating to the stud services provided hereunder shall be the responsibility of Owner. Those expenses include, veterinarian (both Alliebeck's and Owner's) fees for the collection and shipment of semen; for side by side artificial insemination, for surgical implant or transcervical insemination, container fees and deposits, progesterone tests, shipping fees for semen and/or the Bitch, courier or delivery fees, and boarding fees after 7 days. Owner shall not be responsible for the costs of any natural breeding or boarding fees for up to 7 days. In the event the Bitch is boarded with Alliebeck for natural breedings or side by side AI, Owner agrees to the attached Boarding Addendum.


Alliebeck agrees to provide the following stud services from the Stud Dog to the Bitch:

- (a) Services to the Bitch on her current heat cycle;
- (b) Services will be provided either by natural breeding, side by side artificial insemination or shipped fresh chilled semen (must inquire if frozen semen is available);
- (c) If shipped fresh chilled semen is requested, semen for two breedings, subject to other previously scheduled breedings of the Stud Dog, shall be provided, at Owner's expense;
- (d) If by natural breeding, breedings from estimated ovulation date for as long as the Bitch will stand, occurring in intervals of no more often than every 30-36 hours and not longer than 60 hours;
- (e) If frozen semen is requested, only one shipment will be made available and Owner shall be required to inseminate by surgical implant.

Alliebeck shall not be required to provide stud services if the following conditions are not met by Owner:

- (a) The deposit is paid in good funds;
- (b) In the case of a natural breeding, a brucellosis certificate showing the Bitch seronegative;
- (c) Appropriate and timely progesterone testing to accurately determine optimum breeding dates of the Bitch, regardless of the method by which the Bitch is to be bred;
- (d) Artificial insemination by a veterinary clinic, unless otherwise agreed in writing by Alliebeck;
- (e) Completion and delivery of the Shipping Instructions attached hereto, if shipped semen is required;
- (f) Completion and delivery of the Boarding Addendum in the event of boarding of the Bitch;
- (g) Satisfactory Clearances provided;
- (h) If shipped semen is to occur or the Bitch is not viewable by Alliebeck; submission of photos or videos of the Bitch;
- (i) Copy of the Bitch's AKC Registration and pedigree; and
- (j) Delivery of a fully signed copy of this Contract.

Owner agrees that no puppy resulting from this Contract shall be sold to dog brokers, litter lot buyers or puppy mills; pet retail stores; raffles; auctions; purchasers outside the USA and Canada



without Alliebeck's written consent, agents of foreign purchasers or for laboratory or testing purposes. Owner further agrees that each puppy resulting from the stud services under this Contract shall be sold, in the case of pet puppies, under contracts requiring the new owner to spay or neuter the puppy at appropriate times and, in the case of show quality puppies, under contracts that require the new owner to use reasonable efforts to show the puppy and if the puppy is bred, the new owner will adhere to the GRCA Code of Ethics which includes current Clearances, good temperament and of appropriate breeding age. Owner also agrees to use their best efforts to require all homes for puppies to register their puppy with the American Kennel Club.

BOARDING ADDENDUM

The undersigned hereby agrees as follows:

1. Care. Alliebeck will handle the undersigned's (Owner's) Bitch named and described below, with due diligence and reasonable care as described in this Addendum and in accordance with Owner's reasonable written instructions upon the time the Bitch is delivered into Alliebeck's possession. Alliebeck shall not be responsible for any claims, injuries, death or damages caused by any carrier used by Owner. Owner agrees to pay Alliebeck for all services rendered and expenses incurred for the care of the Bitch.

2. Vaccinations. Alliebeck reserves the right to verify current vaccinations including bordatella at the time the Bitch is brought to Alliebeck. In the event that vaccinations are not current within the last three years including Rabies, and that bordatella is not current within the last 12 months, Alliebeck reserves the right to have the Bitch vaccinated at Owner's expense.

3. Sickness or Injury. If the Bitch becomes ill or injured, as determined by Alliebeck, Owner shall be notified at the phone number provided below. Alliebeck will attempt to contact the veterinarian designated below. In the event the veterinarian listed below is not available or is located more than 30 miles away, Alliebeck's veterinarian will be contacted. If the Bitch's condition demands immediate attention, Alliebeck has the right to transport the Bitch to an animal emergency center, at Owner's expense. If the Bitch is to be administered medication or supplements, during the course of boarding, Owner shall provide all medication and supplements to Alliebeck. Alliebeck shall not be required to fill any medication or supplement.

4. Liability. Alliebeck is not liable for, and Owner will hold harmless Alliebeck, its owners and employees from, any loss, expense, damage or injury to the Bitch due to disease, death, injury, failure to observe illness, another pet, administering over-the-counter drugs, veterinarian care, medication supplied by the Owner, or natural disaster. Alliebeck is not liable for and the Owner hereby holds harmless and indemnifies Alliebeck, its owners and employees for any loss, expense, claim, cause of action, damage, or cost resulting from the injury or harm to other persons, animals or property caused by the Bitch. In the event Alliebeck, its employees or agents are injured by the Bitch, Alliebeck reserves the right to charge the cost of the expenses associated with the injury to the Owner's account. Owner understands that Alliebeck does not provide veterinarian services or medical advice.

5. Ownership. The undersigned represents that he/she is the legal owner or an authorized representative of the legal owner of the Bitch named below and agrees to the conditions contained herein.
